INITIAL INFORMATION:

On 01-09-15 at approximately 1430 hrs I responded to Turner High/Middle School to meet with Sgt. Palmer. Sgt. Palmer was in the office regarding an incident involving social media messages between a teacher and a student. Upon my arrival I met with Sgt. Palmer, Ryan Bertelsen, and Dr. McCarthy. Bertelsen is the Turner High School principal and Dr. McCarthy is the Turner School District superintendent.

Sgt. Palmer stated that [REDACTED] a high school student, reported that he has been receiving messages through Snapchat from one of his teachers. [REDACTED] reported that the messages contained sexually suggestive photos and text. Sgt. Palmer then showed me a short written statement from [REDACTED]

In the statement [REDACTED] stated that a teacher, Dayleen Yoerger was "sexting" him and Yoerger did not want [REDACTED] to tell anyone. [REDACTED] also stated that Yoerger sent him images of her in the bathtub. [REDACTED] stated that the images were, "close to nude, but not fully showing anything." [REDACTED] also stated that he received messages from Yoerger that referenced wanting to have sex in the storage room or meeting him somewhere. [REDACTED] stated that Yoerger's Snapchat user name is "dayleen09" and his Snapchat user name is [REDACTED]. After reading the statement I had [REDACTED] come to the office and I interviewed [REDACTED]

CONTACT WITH [REDACTED]

During the interview I asked [REDACTED] to tell me about the messages he was receiving from Yoerger. [REDACTED] stated that approximately one month ago he was sending Snapchat messages to friends while he was in Yoerger's class. Yoerger asked [REDACTED] what he was doing and he told her. Yoerger then commented about [REDACTED] having Snapchat. [REDACTED] stated that Yoerger started coming to his basketball games and on one occasion asked [REDACTED] if he figured out her Snapchat user name. [REDACTED] stated that he made a few guesses about her user name and eventually figured it out. After [REDACTED] figured out Yoerger's Snapchat user name he sent Yoerger some messages regarding what he was making in Yoerger's foods class.

[REDACTED] stated that a few messages were sent back and forth between him and Yoerger. [REDACTED] stated that these messages were just normal messages but soon the messages changed. [REDACTED] stated that he would send group messages to people on his friends list. Yoerger was included on this list. One message that [REDACTED] sent was of him with his shirt off. [REDACTED] stated that he started to receive messages from Yoerger that would include images of her partially clothed, but never of her breasts or pubic area. [REDACTED] stated that the images seemed sexually suggestive in nature and were accompanied by text that talked about wanting to have sex in the storage room or meeting somewhere.

██████████ stated that he did not recall sending any suggestive messages or images to Yoerger. ██████████ stated that he and Yoerger never had any person to person contact other than the normal contact at school. ██████████ stated that he was getting "creeped" out by the messages, so he told his mother that he was receiving messages. However, ██████████ did not explain the content of the messages. ██████████ stated that his mother told him to delete her from Snapchat and ignore Yoerger. ██████████ stated that approximately a week ago he did block Yoerger from his Snapchat.

██████████ stated that he told a few of his friends about the messages, including ██████████. ██████████ stated that ██████████ saw a few of the messages. After speaking with ██████████ he returned to class and Bertelsen called ██████████ into the office.

CONTACT WITH ██████████

During the interview with ██████████ she stated that she did see a few of the Snapchat messages that were sent by Yoerger and received by ██████████. ██████████ stated that the messages contained what she considered "flirty" images. ██████████ stated that the messages contained images of Yoerger showing her face and cleavage as well as text stating if ██████████ could sneak away she would make it worth his while. ██████████ stated that on New Years she and other friends were hanging out with ██████████. ██████████ sent a group photo of him and his friends to Yoerger. ██████████ stated that she believed the group photo that was sent was meant to tell Yoerger that ██████████'s friends also knew that Yoerger was sending him messages. ██████████ stated that after this message was sent she saw a message from Yoerger that stated something similar to, "I trusted you, if you are going to be like that we can't have a relationship."

FOLLOW UP:

The interview with ██████████ was concluded and she returned to class. Bertlesen and Dr. McCarthy stated that Yoerger was being placed on administrative leave pending the investigation. While interviewing ██████████ and ██████████, Sgt. Palmer was at the PD sending an account preservation request to Snapchat for ██████████ and Yoerger's accounts. Sgt. Palmer advised me that Snapchat confirmed receipt of the preservation requests. I informed Bertlesen and Dr. McCarthy of this.

I returned to the PD and completed a search warrant affidavit. I contacted Deputy District Attorney Perry Foltz about the investigation. Foltz requested a copy of the affidavit be emailed to him for review prior to taking it to a judge. Due to the weekend I will email the affidavit to Foltz on Monday. I placed the copy ██████████ statement into evidence with evidence tag #00001.

This investigation is still active as I await a search warrant and pending account information from Snapchat.

 On 01-27-15 at approximately 1654 hrs while I was off duty I received an e-mail response from Snapchat Inc regarding the search warrant that I sent them on 01-16-15. The e-mail stated that Snapchat Inc received the search warrant and were complying with the search warrant. The e-mail also stated that Snapchat Inc burned the user account data to CD and sent it to me via Fed Ex with tracking #772731682209.

On 01-30-15 at approximately 1415 hrs I returned to work after my scheduled days off. When I arrived at the PD I was informed by Sgt. Palmer that the Fed Ex package arrived and she had been looking through the Snapchat Inc data on the CD. Sgt. Palmer stated that she was not able to find any data for the user name, "dayleen09."

I took possession of the CD and looked through the data files. I was able to find data logs for the user name, [REDACTED], but I could not find any data for "dayleen09" except for a PDF document stating the "dayleen09" account had been deleted. This PDF document showed a date of 01-07-15. The data logs for [REDACTED] did not show any contact between [REDACTED] and "dayleen09." During the initial interview of [REDACTED] and [REDACTED] they both stated that there was communication between [REDACTED] user name of "[REDACTED]" and Dayleen Yoerger's user name of "dayleen09."

I contacted Snapchat Inc. regarding the logs not showing communication between the two user accounts. Snapchat Inc advised that when an account is deleted it wipes the system of that account. In other words, when the "dayleen09" account was deleted it removed any and all records pertaining to that user name, including any communication logs. Snapchat Inc advised that this could explain why there were no logs showing communication between the two user accounts.

Police were not involved in this incident until 01-09-15. The preservation request to Snapchat Inc was submitted and effective on both accounts within two hours of police contact. However, according to the Snapchat Inc data logs the user account for "dayleen09" was deleted at least two days prior to police contact. Therefore, any record of the user account "dayleen09" was deleted prior to the preservation request.

After looking through the data and communicating with Snapchat I placed the data CD into evidence with evidence tag #00002. I completed the Return of Officer report which listed the data CD as the only evidence recovered as a result of the search warrant. The Return of Officer report will be delivered to the Rock County Clerk of Courts on Monday, 02-02-15.

I contacted Turner High School Principal Ryan Bertelsen and informed him of the results of the search warrant. I also advised Bertelsen that due to lack of evidence there were no criminal charges against Yoerger.
